Description:

This brief learning is for providers of sexual and reproductive health services working in diverse clinical settings (e.g., family planning, primary care, hospitals, and those funded by Title X) and providers working in other settings that may identify SRH needs and make referrals. It is designed to equip healthcare providers with essential skills and knowledge to deliver high-quality, person-centered sexual and reproductive health (SRH) services, fostering equity, inclusivity, and improved health outcomes for diverse populations.

Objectives:

By the end of this activity, participants will be able to:

- Discuss the importance of aligning contraceptive choices with patients' values, needs, and preferences.
- Describe at least three strategies to reduce barriers to contraceptive access by integrating self-care options for patients into clinical practice.
- Select appropriate management plans for a variety of sexually transmitted infections using CDC's STI Treatment Guidelines.
- Identify at least three strategies to address stigma and confidentiality concerns in STI and HIV care.
