#### **Description:**

Expanding pre-exposure prophylaxis (PrEP) access requires strong community partnerships and strategic promotion of available services. This final session will explore how clinics can effectively collaborate with community organizations and outreach programs to ensure people know PrEP is available, accessible, and easy to get. Participants will also learn about financial considerations and funding strategies to sustain PrEP services long-term.

#### **Learning Outcome:**

Participants will be able to establish collaborative partnerships and implement strategies to promote clinic-based PrEP services while addressing financial sustainability.

#### **Objectives:**

- Identify key community partners that can help connect people to PrEP services
- Develop strategies to promote clinic-based PrEP services and ensure the community knows how to access them
- Explain financial considerations and funding opportunities for sustainable PrEP service delivery
